Vibration Monitoring	 Monitoring ground-borne vibrations – GBN in the premises of an ancient fort on the Kempegowda International Airport metro rail line, near Chikkajala Vibration sensors in 3D directions to be configured at each location and vibration data to be recorded for a continuous 24 hours in a single schedule. At least 4 places near "CHIKKAJALA FORT" to be covered for measurements in a single 24-hour window. The testing agency has to use ultra-low frequency vibration sensors (0.01Hz onwards till 500 Hz) and appropriately couple them to the ground surface at the test site location. 	and technical evaluation of the vibration severity are to be conducted as per DIN 4150-3 standard, both horizontal and vertical vibrations are to be monitored and measured at site.

Note:

- 1. The report needs to contain all the details of the testing procedure, instrumentation used, data, and results of testing in comparison to the reference standard (peak particle velocity / Vi Max)
- 2. The sensors and instrumentation to be used are to be traceable to National standards and valid certificates are to be produced along with test reports.
- 3. The data processing shall be carried out on reliable software tools and the inference of the data to be drawn as per the applicable guidelines.
- 4. The testing agency shall possess a valid ISO 9001:2015 quality procedure certificate, additional certifications are considered as an advantage.

TERMS AND CONDITIONS

1. Quoted price:

- (a) The rate shall be quoted legibly and separately.
